FIRST BYE-LAWS OF HORSHADER DEVELOPMENT LIMITED

Ordinary Membership

1. Ordinary membership - Eligibility Condition

Subject to Clause 4 of the company's Articles of Association, Ordinary Membership of the Company shall be open to all individuals over 18 years of age who are either:

- a) Resident (as hereinafter defined) within the crofting townships of South Shawbost, Dalmore and Dalbeag, or
- b) Resident within the Isle of Lewis and registered with the Crofters Commission as the tenant of a croft within the crofting townships of South Shawbost, Dalmore and Dalbeag.

For the purposes of the above "resident" shall mean:

- a) Actually residing at the qualifying address for not less than nine months out of every twelve, or
- b) Having one's only permanent home at the qualifying address and residing there at all times other than (i) when working away from home for not more than three months at a time or on holiday or (ii) when following a course of full-time education.
- c) A full-time resident can apply to become a member of Horshader Community Development Trust after living in the area for three months.

2. Ordinary membership - Director Position

An Ordinary member can be nominated for election as a Director after one year of membership if nominated and seconded by a member of HCD Trust. An associate member cannot be nominated as Director or vote. Directors are elected by members at the AGM.

3. Ordinary membership – Termination

- a) In addition to the circumstances outlined in Clause 8 of the Company's Articles of Association where under a Membership shall be automatically terminated, a Member shall also cease to be a Member in the event of that Member ceasing to fulfil the eligibility condition for admission to Membership applying at the time of his or her admission. At the discretion of the Board any such former Member may be admitted as an Associate in accordance with Clause 10 of the Company's Articles of Association.
- b) The Board may at any time suspend or terminate the Membership of any Member deemed to have acted or be acting against the interests of the Company. Any Member or former Member whose Memberships is suspended or terminated under this bye-law may appeal for reinstatement at the next or any subsequent general meeting of the company and attend and be heard at such meeting for the purpose of making such appeal.
